E-MAIL PRIVACY

Your e-mail address will only be used within the Greater Salina Community Foundation. The GSCF does not share, sell or rent e-mail addresses to anyone outside the organization. USE OF IP ADDRESSES AND COOKIES

A unique number called an IP address identifies every computer on the Internet. Each time you connect to the Internet your machine is assigned an IP address. An IP address is a number that identifies each sender or receiver of information that is sent in packets across the Internet. The

GSCF may use your IP address to help diagnose problems with our server, and to administer the GSCF website.

"Cookies" are small pieces of information that are stored by your browser on your computer's hard drive. Most Web browsers automatically accept cookies, but if you prefer, you can edit your browser options to block them in the future. The GSCF uses cookies to maintain user session identity, and, in some non-member areas, to store your username and password locally for ease of access.

The GSCF may also collect certain demographic information about visitors to its website through the use of cookies. The GSCF only uses this data to improve the overall website and for internal business purposes.

SITE/MEMBERSHIP REGISTRATION FORMS

The GSCF website registration forms require users to give us contact information (such as name and e-mail address), method of payment, and demographic information. The GSCF may use customer contact information from the registration forms to send the user information about the Greater Salina Community Foundation. The customer's contact information is also used to contact the visitor when necessary. Information regarding method of payment is collected for member enrollment, registration and to process gifts or grants.

The GSCF website (<http://www.gscf.org>) uses an order form for customers to request information, or make donations. The GSCF collects visitor's contact information (such as e-mail address) and method of payment. Contact information from the order form is used to process orders and to send information about the GSCF. User payment information that is collected is used to check the users' identity and bill the user for products and services. This information is transmitted via a secure e-mail.
